### Michigan Talent Investment

Michigan's future depends on strong talent. Businesses from the Great Lakes Bay Region and across the state rely on schools and skilled trade programs to equip students with the skills needed to succeed in future careers.

At the Bay Area and Saginaw County Chambers of Commerce, we believe it is important to make sure students have access to opportunities to achieve and grow successful careers. #### **Bay City Bridges**

On Thursday, July 11, the Bay City Commission held a public meeting regarding Bay City's two city-owned bridges, Independence and Liberty. During this meeting, each of the three companies that responded to Bay City's Request for Proposal on a Public Private Partnership were given an opportunity to present their respective bids for Independence and Liberty Bridges.

In the coming weeks, it is anticipated the Commission will continue to review all the proposals before them before asking a final decision. The Bay Area Chamber of Commerce will continue to advocate for a resolution that improves community infrastructure and business access.

#### **SAGINAW COUNTY**

Designation facilitates private investment, improves economic development opportunities

For their efforts in establishing a solid foundation to attract private investment and further build on municipality assets, the city of Saginaw has been awarded the Redevelopment Ready Communities (RRC) certification, the Michigan Economic Development Corporation (MEDC) announced.

The MEDC formally presented the award on Friday, June 28 at a special event held in the new SVRC Marketplace.

Saginaw joins 32 other Michigan communities that have qualified as "thoroughly prepared" when it comes to planning and zoning to remove traditional barriers and promote opportunities for prospective investors.

Saginaw County Chamber President Veronica Horn praised the City of Saginaw and Saginaw Future Inc, on accomplishing this outstanding designation. The designation sends a message loud and clear that Saginaw is open for business expansion and attracting new business.

#### STATE GOVERNMENT UPDATES

#### Auto Insurance Reform

On May 30 2019, Governor Whitmer signed SB 001 into law in efforts to lower the state's highest-in-country insurance costs. The bill mandates insurers lower their rates, provide customers choice on personal injury protection (PIP) and stop using certain non-driving factors in rate determination.

#### Infrastructure

Governor Whitmer's proposal to fix Michigan's roads is a 45 cent gas tax increase. As the Governor continues to travel around the state to rally support for her tax increase, no one in the legislature has committed to pushing her plan forward with a 75% unfavorable rate.

Recently, House Republicans have publicized their plans to fix Michigan's decaying infrastructure. They want to scrap the current 6 cent gas tax and move to a pennyfor-penny gas tax or excise tax where every penny spent at the pump in taxes goes into roads. This tax would be approximately 15 cent per gallon and generate \$1 billion for roads

Additionally, Senate Republicans want to move from a tax shift instead of a gas tax with an option for communities to keep money local. Majority Leader Mike Shirkey confirmed that they will put forth a plan that includes refinancing a portion of the state's \$30 billion public teacher pension obligation as a part of their road funding plan. This would be used to back-fill the \$800 billion hole in the School Aid Fund & General Fund that will be created when going from the 6 cent gas tax to a penny-for penny-gas tax.

Meetings between House and Senate Republican leadership have taken place and will continue until they can come up with a comprehensive plan.

There has been no plans for Michigan's roads publicized by House or Senate Democrats at this time.

#### Minimum Wage & Paid Sick Leave

In August 2018, Michigan voters chose to increase minimum wage and paid sick leave without understanding the repercussions it would have on businesses. The legislature amended PA 368 & 369.

In short, the actions of the legislature have been disagreed with and taken to Michigan Supreme Court in regards to the constitutionality of the adopted changes. As the Supreme Court is currently hearing verbal arguments from groups of interest.

#### Recreational Marijuana

In August 2018, Michigan voters made recreational marijuana legal. Under this legislation, persons 21+ can possess, use and grow marijuana. The sale of recreational marijuana will not be permitted by law until the state adopts rules and regulations for those who chose to engage in the marijuana business. The due date for legislature to develop these rules and regulations is December 2019.

Protections for employers exist – employers do not have the obligation to permit or accommodate conduct in the workplace or on the employer's property. Employers retain the right to refuse to hire, discharging, disciplining or taking an adverse employment action against a person with respect to hire, tenure, terms, conditions, or privileges of employment if a person is in violation of workplace drug policy.

#### FEDERAL GOVERNMENT UPDATE

#### Minimum Wage

This month, the Congressional Budget Office (CBO) released a report detailing the impacts of increasing the hourly federal minimum wage to \$15, \$12 and \$10 by 2025.

The results of this report tell us what many businesses already know. Raising the federal minimum wage to \$15 per hour would have negative impacts on business and the economy that far outweigh any positives. While worker income would see an increase, the report finds that up to 3.7 million jobs would be lost, business income would be reduced, prices would rise and the national output would be reduced slightly due to the smaller workforce.

Despite opposition and concerns, the U.S. House went on to pass the \$15 minimum wage increase last week.

#### BUSINESS CLIMATE

To support and improve our region's businesses, we look to promote policies that ensure their well-being.

- Investments and improvements in tourism
- Strengthen local farms and agribusiness interest in the region
- Growth in technology
- Efforts to maintain open markets and trade for Michigan grown and made products
- Reduce unnecessary government regulation of business in the private sector including business rights, employment and compensation

#### HOUSING & REVITALIZATION

Throughout the region, we will work to support streamline programs and incentives that help develop rural areas and rehabilitate housing in our urban cores.

- Downtown Development Authorities (DDA)
- Brownfield Redevelopment programs
- Facade work and downtown revitalization
- Incentives to restore homes in efforts to revitalize the area
