Dear Evaluation Committee,

It is my honor to nominate Mary Storm for the Saginaw Chamber Community Impact Award. As I reviewed the criteria for this award, in my opinion as a non-profit leader, there is no other person that exemplifies these traits more. Mary has an extraordinary commitment to serving and guiding those who work for and with her to ensure high quality medical services and that a pipeline of future physicians is available in this community.

Mary joined Saginaw Cooperative Hospitals, dba CMU Medical Education Partners as the Chief Operating Officer and Director of Legal in November of 2019. She had little time to adjust to her new environment before COVID turned the world upside down. Because of the pandemic, Mary was thrown into a situation where her expertise, calmness and commitment to patient and employee care stood out. This was during the largest expansion in the 53-year history of the organization. Her 27-year experience as a healthcare professional (26 of them in the Mid-Michigan) developed her skills to handle the heavy burden that the expansion and Covid created in healthcare. Mary provides leadership that is unmatched. Additionally, she provides an excellent support system for our employees with exceptional detail. Under her leadership, the organization has grown revenue by 30%, physician faculty by 25 positions (>30%), resident physicians by 30%, and overall staff by 20%. Mary is so unique in her abilities that it may seem that I am exaggerating her skillset, but I am not. Her commitment to this non-profit has made impact never seen previously. The results of her work effort have made a significant impact on our community, Covenant Healthcare, Ascension St. Mary's, and Healthsource Saginaw. Partnership with Great Lakes Bay Health Centers has improved the access to care in both behavioral health and primary care in a patient population that is vulnerable and underserved. A new CMU Behavioral Health Clinic has been opened under her direction which is expanding behavioral health services at a time when it is desperately needed – to all.

As a young mother of three, while working full time, Mary put herself through law school and graduated with honors. She has participated in many volunteer efforts in our community over the years and recently became a member of the Chamber of Commerce Board of Directors.

Mary has made a difference in this organization, and she has impacted the people of this community without any fanfare. Being the individual that she is, she will continue to make a difference for years to come.
