In 2012, Jim sold the ownership to Justin Jaime (son), Jonathan Jaime (son), and Theresa Jaime (daughter in law). These current owners have now expanded in the last 5 years to where in addition to owning this company, they now own Michigan Pipe & Valve – Genesee and Michigan Poly Pipe in Lansing area. They also are ½ owners of Michigan Pipe in Mt Pleasant.

As you can see in above, it's a true established Saginaw County minority family-owned business. Justin and his siblings are involved in the Stevens Center For Family Business @ SVSU, strong supporters of the Mustard Seed House in Saginaw along with assisting several other local causes.

It's a very successful and growing company managed and owned by people that were born, raised, and continue to live in Saginaw County.

Since taking over the company in 2012, Justin, Jon, & Theresa have taken the company from one location (headquarters in Saginaw) with approx. \$9 million in annual sales, to 4 locations with approx. \$19 million in annual revenues.
