Ken LeCureux and Pharrington Douglas have poured their hearts into the city of Saginaw. Together, they developed the Urban Tennis Foundation in 2006. The UTF operates and maintains the city's only municipal tennis courts and just recently, raised \$1.9M of a \$2.2M budget to replace the deteriorated Garber Courts with 8 tennis and 8 pickleball courts, a gathering building for off-court teaching, picnic area.

Since its inception, the UTF has served thousands of kids by hosting clinics and tournaments. The tennis facilities and related activities provide opportunities for kids to learn to play tennis. The UTF also conveys an important message to our kids – that they are worth the investment and so is our community.

Living in a post-industrialized city has its challenges. A big part of that challenge is re-imagining what's possible for our future. Ken and Pharrington have applied their passion for tennis to their love for Saginaw to not only imagine a brighter future, but to do something about it.
