Record Turnout in Michigan Midterms

BALANCE OF STATE GOVERNMENT SHIFTS



What Should Saginaw Businesses Expect in New Term?

Michigan voters took to the polls on November 8th in record-breaking numbers. Secretary of State Jocelyn Benson announced that 4.49 million Michiganders voted in the midterm election, breaking the previous record, set in 2018, of 4.34 million. In Saginaw County, 82,239 ballots were cast.

At the polls, voters shifted the balance of the state legislature. For the first time since 1984, the Michigan Senate, House of Representatives and Governor's office will all be held by Democrats. The Secretary of State and Attorney General races were won by Democratic incumbents, and all three statewide ballot proposals passed.

Economic Development Opportunities

How should the Saginaw business community interpret the results of the elections? Representative Amos O'Neal (D, 94th district) finds much to look forward to in the new term. "To be honest, what am I not excited for?" he says. "This upcoming year, Michiganders will see many robust actions taken to promote a healthy economy across the state. This was not only ensured with the passage of the 2022-23 budget, but can also be seen in the many new investments sprouting around the state, bringing many new jobs with them." In particular, he notes the higher demand for electric vehicles as a strong opportunity for the state's economy, predicting that "Michigan will see a rise in good-paying manufacturing jobs."

Senator Ken Horn (R, 32nd district) agrees that economic development, especially in the manufacturing sector, is on the horizon for Michigan. "There are so many opportunities up ahead for us in Saginaw and across the state," he says. "Those opportunities are in electrification of cars, autonomous mobility like driverless cars and drones, in aerospace and in copper manufacturing for the satellite industry as we build 5 and 6G networks."

Developing the Workforce Through Education

Representative O'Neal points to funds he worked to secure for the Saginaw region in the past term as a hint of the types of projects and investments the region can look for in the upcoming term, such as a \$1 million dollar investment in the Bridge the Gap Foundation, a training program that teaches welding skills, and a \$22 million dollar funding package for Saginaw Valley State University to renovate Brown Hall. Each of these investments will help to develop the workforce by improving education opportunities.

Senator Horn also sees building the workforce through education as a significant focus of Michigan's future. "We need to invest in universities and colleges to train people for Michigan jobs. We need to incentivize kids to stay in the state when they graduate; we need to attract people here, and we need universities and colleges to train these people for jobs right here in the state," he says.

Senator Horn sees education as something that needs to be woven through all workforce development projects. "I'm advocating a plan called Project 1MP to bring one million people to Michigan to drive manufacturing growth, but we need our education system to support that as well; we need people to be trained to join manufacturing industries because that's where we have real growth opportunities," he says.

Representative O'Neal similarly sees the new legislature as an opportunity to grow the workforce. "I'm a strong advocate for the Michigan Talent Pipeline," he says, "and with this year's budget investments into teacher recruitment and career and technical training, small businesses should see a growth in skilled trade workers."

John Kaczynski, executive director of government and community affairs at Saginaw Valley State University, also predicts a focus on education. "This new generation needs to be properly trained," he says. "I project funds going to tuition-free pathways into trade schools, technical vocational programs, and teaching and engineering programs."

Potential Pitfalls

The Michigan Chamber of Commerce sees potential recession as a chief concern, and hopes legislators pay close attention to the issue. "As the economy tightens and a recession looms—and historic inflation, workforce shortages, and supply chain issues continue—public policy issues that affect Michigan's job providers are more important than ever," says Jim Holcomb, chamber president.

Both Senator Horn and Representative O'Neal see national inflation rates as a concern, but neither thinks inflation should be the driving force in how businesses make decisions because lawmakers are aware of the challenge and are working to shift the trend. "We will continue to support hard-working families to blunt the effects of inflation," Rep. O'Neal says. "We'll work together to make meaningful changes for everyone in our state."

"For business, steady as she goes," Senator Horn advises. "Inflation and rising interest rates are things to watch for, but you shouldn't let them stop you from moving forward."

Working Together to Drive Saginaw Growth

Senator Horn sees something special about the political landscape in Saginaw. "There's something different about our community in Saginaw," he explains. "We have strong relationships between our legislators. We get along and work together well; we're bipartisan in our area. We are well positioned to make positive changes in the coming year because we work together and there's a lot of opportunity ahead."

Kaczynski also notes opportunities on the horizon. "A lot of items on the Democrats' agenda might be in businesses' interests," he explains. "Making transit more affordable will help to increase the workforce. More money into childcare will help parents get to work. Addressing the big workforce housing shortage in the state will help. Education and talent development will benefit our business community."

The Michigan Chamber echoes Senator Horn's bipartisan focus. "Politics has become far too divisive," says Holcomb. "We must embrace the opportunity before us to reset the landscape by improving civility in public debates and focusing on impactful policies." His advice to both the business community and the new legislature is to be committed to civility. "More bipartisanship, civility, and pragmatic problem solving can make an important difference. We're stronger together."

Representative O'Neal agrees. "I want a thriving Saginaw community," he says. "We are all in this together."


